WOMAN STABBED, SUSPECT CAUGHT

A Las Vegas woman was stabbed in the heart at 9:10 a.m. Tuesday in a liquor store-bar and was near death in Southern Nevada Memorial Hospital, Metro Police said.

Being kept alive by hospital life support systems is Marie Banks, 29, of 516 Jackson Ave.

Officers said her assailant, Terry Collins, 31, fled after the stabbing at Friendly Liquors, H and Owens

streets, but was arrested less than an hour later at Jerry's Nugget casino in North Las Vegas.

Collins, described as Banks' former boyfriend, was jailed on a charge of attempted murder.

The stabbing resulted from an ongoing dispute between the couple, police said.

The weapon was described as a knife with a six-inch blade, which was buried to its hilt in Banks' chest.

MAN ORDERED TO TRIAL FOR STRANGLING ESTRANGED WIFE

A District Court trial was ordered Tuesday for a Las Vegas man charged with battery for allegedly attacking his estranged wife. Justice of the Peace Joe Bonaventure ordered the trial for Bobby L. Brown, 29, 1228 McWilliams Ave. after presiding at a preliminary hearing.

The only witness called by Deputy District Attorney Tom Green was the alleged victim, Bonnie J. Brown.

The woman testified Brown entered her residence about 11 a.m. Sept. 26 and choked her until she blacked out. She said he has threatened to kill her. The woman was treated for her injuries at North Las Vegas Hospital, according to testimony. A Nov. 9 arraignment was scheduled before District Judge Joseph Pavlikowski. Brown is being held in lieu of \$50,000 bail.
