Congress and other anti-apartheid supporters.

In fact, both black and white South Africans have been murdered by this "government apparatus" of apartheid. We believe that President de Klerk knew about these illegal and barbaric actions of the "third force" long before the public disclosures of the past few days. The old saying, "The truth buried always eventually comes to light," is quite applicable to this last difficult stage of the historic struggle to dismantle the brutal institutionalized system of racism known as apartheid.

As we have previously argued, much of the dramatic increase in the fratricidal warfare between the African National Congress and Chief Buthelezi's

Inkatha group has been orchestrated by forces within the military and government. These latest revelations of the extent to which repressive forces in South Africa have gone to destabilize the situation inside the nation, are also indicative of how the military-intelligence sector of the government sought to "desta-"

## FADING TO BLACK

Finally, the truth begins to surface that statistics on the numbers of Black and White people in the U.S. aren't being accurately reported. In fact, racial demographics are likely so skewed that they aren't even close to being factual. The impact of this discovery is mind boggling.

This startling news was revealed by a team of researchers who conducted a federal study of infant mortality rates for minority groups. According to the study, mind you, Whites received different racial classifications on their birth and death certificates only 1.2 percent of the time, while Blacks were inconsistently identified 4.3 percent and other races a whopping 43.2 percent.

The researchers found that true infant mortality was overreported for Whites and underreported for Blacks and other so-called minority groups.

There are many implications in this report. Until now we have been led to believe that certain minorities were more susceptible to certain diseases and health conditions. With what we now know, those former findings have little credibility. For all we know, true mortality rates for minorities could be the same as for Whites.

Then there's the question of race designation on birth certificates. Ever wonder how a person's race is determined at the time of birth? Apparently there is no consistent standard. Anyone can be designated White, Black or whatever. It's a judgement call. All a doctor, public health officer or hospital administrator has to do is wave a magic wand and declare what race you are. Many times only the race of one parent is considered. I'm sure you may even know at least one person who is obviously Black but who is listed as White on his or her birth certificate.

What does all this mean? Who cares? What difference does it make?

Just look at the evidence around you. How often have you seen people of apparent mixed race heritage who lead White lives? There are many people who fall into this category who either pass for White or who are accepted as equals by the White community. But from a visual standpoint, when you look at them, there's a tell-tell sign that they are of mixed race ancestry.

In America today, people of mixed race ancestry are being accepted as White in greater numbers than ever before.

Slowly but surely, the whole truth begins to emerge.
