Biographical Note

Edward and Mary Von Tobel were one of the early families to arrive in Las Vegas, Nevada in 1905. In that year, the family founded the Von Tobel Lumber Company, which remained in operation until 1976 as one of the longest family-owned businesses in Las Vegas, Nevada. Sons Edward Jr. and George Von Tobel opened several Von Tobel retail hardware stores in Las Vegas in the 1950s and 1960s. The family was also active in early Nevada Republican party politics and George Von

Tobel served as a Nevada Assemblyman. In the 1960s, the Von Tobel family focused their attention on real estate, and they were involved in buying, selling, and appraising numerous properties in and around the Las Vegas valley. Most Von Tobel retail stores closed or were sold to other companies in the 1980s. George Von Tobel passed away in 2003 and his brother Edward Jr. passed away in 2009.

Scope and Contents Note: The Von Tobel business records series dates from 1916 to 1995 and consists of daily operation ledgers and insurance information from the lumber company. Additionally, the series contains financial and human resource records, store newsletters, and internal memos from Edwards Von Tobel's Hardware Store No. 301 collected by store employee Marie Imus. The series also contains photographs of the first Edward Von Tobel Hardware Store, and photographs and ephemera related to the lumber and hardware store businesses. The series also contains information about Von Tobel's hardware store shutdown and take over by Builder's Emporium, as well as information about other competing hardware stores, such as Ole's and Ernst.
