Historical Background

The Nevada-Utah Mines and Smelters Corporation purchased the Manhattan mine in Pioche, Lincoln County, Nevada in 1907. The Nevada-Utah Mines and Smelters Corporation participated in the second gold and silver mining boom in Lincoln County, which was made possible by the construction of the Union Pacific transcontinental railroad through Lincoln County, with a branch

line connecting to Pioche. The company sold their assets and stopped mining production in 1912 due to bankruptcy.
